We are going to be forced to use an automated system for mailing quarterly newsletters and the annual directory. If we don't have all of the address information correct, it could be quite costly.

#### 2014 Razorback and Lady Razorback

As everyone should know by now, the 2014 Razorback and Lady Razorback 2 year old stakes races will be held at Remington Park this year, instead of Louisiana Downs, where it was previously held for 20 years. These races will run November 8th. Closing for entries is Wednesday October 29th.

Page 9 lists all registered Arkansas-bred 2 year olds that have been nominated to the Arkansas-bred stakes program. If your horse is NOT listed and you desire to enter him/her in one of these races, the \$2,500 Late Nomination fee must be delivered to the ATBHA office on or before Tuesday, October 28th so we have sufficient time to notify Remington Park's racing office of a new nomination to the list previously provided to them.

Each entry will have a \$500 to enter and \$500 to start fee that will need to be paid to the Remington Park Horsemen's Bookkeeper prior to entry or start.

For all who are going to Remington Park on November 8th, you can contact Sandy Steinberg, Remington's Horsemen's Liaison who can help you with lodging, dining within their building or answer any questions you might have regarding what they offer owners of horses in stakes races at their facility. ■reports state

Live Foal/No Foal Report (LF/NF). "Within 30 days of the birth of a foal, the owner, breeder or authorized agent must complete a Live Foal/No Foal Report. The LF/NF indicates the exact date of foaling, the sex of the foal and the state or Canadian province where the foal was born. It is at this stage of the registration process, that the breeder of the foal and correct address for receiving correspondence and the Certificate of Foal Registration must be supplied. In the event the breeding did not result in pregnancy or the pregnancy was lost during gestation, a No Foal Report should be completed and submitted to The Jockey Club as soon as possible.

There is no racing Easter Sunday, April 5.

He leaves behind to cherish his memory, his loving wife of 40 years, Betty, one son, James Hale and wife Lorene of Waldron, Arkansas, and one daughter, Gina Pitts and husband Bryan of Tulsa Oklahoma. Papa will forever remain in the hearts of his grandchildren, Jimmie Lee Hale, Nikita Hale, Austin Hunt, Tyler Pitts, Logan Pitts, and Aaron Pitts. #### **OBITUARIES**



JAMES E. DANAHER - 92, of Pine Bluff, died Saturday, July 26, 2014. Mr. Danaher attended East Side Junior High School in Little Rock, where he delivered milk before school for Dixon Dairy. He worked with Jerry Dean, who became National Chaplain for the Army. After school and summers he worked as a messenger for Owens, Ermine & McHaney Attorneys hand delivering correspondence to local businesses. His family moved to Dallas, Texas, where he graduated from Highland Park High School. He studied

geology at Texas A&M.

The family moved to Wichita Falls, Texas, where they owned the Chrysler-Plymouth auto dealership and a parking garage. He volunteered into military service in 1943 doing his basic training at Majors Field, Texas. During World War II, he flew the P-38 Lightning with the 54th Fighter Squadron out of Attu in the Aleutian Islands and was there on D-Day. He remained in the reserves and was a test pilot for Douglas Aircrafts' B-17. Mr. Danaher was recalled during the Korean conflict to open an IFR pilot-training school in Valdosta, Georgia. In the 1950's, he and his brother prospected for uranium in Utah selling their claims to producers.

Mr. Danaher later moved his family to Pine Bluff, Arkansas, where he raised cattle while clearing land for farming, opened the Kerr McGee service stations, built and operated Island Harbor Marina as well as digging the canals to develop Island Harbor Estates Subdivision and later forming the Island Harbor Homeowners Association and Volunteer Fire Department.

He was an active member and director of the Pine Bluff/Jefferson County Port Authority from 1978 to 1990 receiving the Outstanding Leadership Award as the Chairman from 1985-1986; a senior member of the U.S. Power Squadron and a member of the P-38 National Association.

Mr. Danaher, a long time member of ATBHA, claimed his first thoroughbred race horse in 1986. That venture expanded to include building his own training track and stable of "Humble" horses. He began his stables with the Bible precept "he who humbles himself shall be exalted and he who exalts himself shall be humbled". He was owner, breeder, trainer and his stable of "Humble" horses have won many distinguished racing awards. He retired from racing in 2007. He received three awards in 2011 from the Arkansas Thoroughbred Breeders & Horseman's Association for stakes winning horses of 2010. He received a Silver Certificate as a member of Arkansas Council Race Track Chaplaincy.

In 2010, he was honored at the Arkansas-Oklahoma Port Operator's/U.S. Army Corps of Engineers Navigation Conference as a tribute to those who have contributed outstanding service to the development of the Arkansas River, its basin and the McClellan-Kerr Arkansas River Navigation System.

He is a long-time member of Trinity Episcopal Church of Pine Bluff.

Mr. Danaher was preceded in death by his parents; son, Patrick Danaher and grandson, Matthew Danaher. Survivors include two sons, James Danaher, Jr. of Pine Bluff and Tom Danaher (Kelly) of Norman, Oklahoma; three daughters, Mary Gretchen Castle of Fort Collins, Colorado, Madeline Udashen of Dallas, Texas and Betty Danaher of Dallas; a brother, Tom Danaher of Wichita Falls, Texas and his companion of many years and caregiver during his last few years, Retha Hankins. Also surviving him are he and Retha's grandchildren and great grandchildren.

Mr. Danaher, aka Mr. Humble, as he is called by many in the thoroughbred industry, will be missed by all of us whose life he touched or of whom were fortunate to have known him. Our condolences are with the entire Danaher family. Rest In Peace dear friend!

**DON GRISHAM** - 84, of Hot Springs, who lived out his boyhood dream of covering races at the hometown track where he once watched the action through a fence, passed away August 4, 2014. He was born in Hot Springs, Arkansas to the late Allen Rueben and Opal Larue (Chitwood) Grisham. Don graduated from what is now Henderson State University. He combined his love of journalism and thoroughbred racing into a career that began with the Arkansas Democrat. He then

served as a columnist for The Daily Racing Form for thirty four and one-half years. His main beats were Oaklawn and the Chicago tracks, covering the first Arlington Million for the public in 1981. He also reported on the 1983 Super Derby at Louisiana Downs won by Sunny's Halo, the first Oaklawn horse to win the Kentucky Derby. After retirement, Don performed media relations for Oaklawn Park Race Track. He won many lifetime honors for his journalism endeavors around the world, including his induction in 2009 into the Arkansas Walk of Fame. Each year on April 6, the City of Hot Springs recognizes Don's contributions with "Don Grisham Day".

Don is preceded in death by his parents and sister, Charlotte Hurst. He is survived by his wife, Iris Grisham of Hot Springs, Arkansas; brother Danny S. Grisham (Retta) of Steilacoom, Washington; brother-in-law Overton Hurst (Gayle) of Hot Springs, Arkansas and a host of nieces, nephews and their families.

He will be missed by the many many people with whom he encountered during his years as a journalist. Our condolences are with Iris and the Grisham family.

### C O R R E C T E D MINUTES OF MEETING OF BOARD OF DIRECTORS OF ARKANSAS THOROUGHBRED BREEDERS' & HORSEMEN'S ASSOCIATION

A meeting of the Board of Directors of Arkansas Thoroughbred Breeders' & Horsemen's Association was held Wednesday, April 2, 2014 at 1:00 p.m. at the ATBHA office located at 161 Golf Links Road, Hot Springs, Arkansas.

President McDowell called the meeting to order. All directors were in attendance, with the exception of David Whited, representing a quorum.

President McDowell asked if there were any corrections or discussion regarding the Minutes from the March 5, 2014 meeting of the ATBHA Board of Directors. There being none, Linda Anderson made a motion to accept the Minutes as presented, seconded by Val Yagos, and unanimously approved.

Linda Anderson was asked to explain her suggestion to alleviate future stakes races from being cancelled. She said she had talked to others and suggested a person from the Horsemen's Committee be delegated to work from the Supplementary Nomination List provided by Oaklawn's Racing Office prior to the date of entries, to assure enough entries would be made for this race to run. She further said she thought Lewis Mathews, who is on the Horsemen's Committee, would be a good person for this. After brief discussion, Motion was made by Val Yagos, seconded by Tommy Ives, that Lewis Mathews be the delegated person from the Horsemen's Committee to work with Oaklawn and those that have submitted a supplementary nomination to assure that there are enough entries to alleviate future stakes races from being cancelled. A vote was taken and Motion passed unanimously.

The above led in to discussion regarding MSW races for registered Arkansas-breds during Oaklawn's 2015 live meet. It was agreed that the Horsemen's Committee have the authority to address this subject with Oaklawn at the upcoming meeting or at some other meeting prior to the condition book for 2015 being written.

Next was discussion concerning the timing of the restricted MSW races during the 2014 live race meet. Bill asked Deana, since The Horsemen's Committee had not met with Oaklawn yet this month, to schedule a meeting with Jed Doro and Pat Pope as soon as possible, this being the last meeting during the live meet, so scheduling of the restricted MSW races in 2015 could be discussed.

The 2014 Razorback and Lady Razorback was the next item on the agenda. President McDowell said that he had again talked with Mike Shamburg at Remington Park and he will send a letter of agreement to him setting forth the agreements of both parties to run the 2014 Razorback and Lady Razorback at Remington Park, Saturday, November 8, 2014. During discussion on these two races and how the purses are funded, Tommy Ives made a motion to raise the purses of both races to \$75,000, seconded by Susan Watkins. A vote was taken and the Motion failed by a count of 6 agains and 2 for. The purse will then remain \$50,000 for each race with ATBHA being responsible for the entire purse of both races. We will further explain to Remington Park officials that a \$500 to enter and \$500 to start fee will be collected at the date of entry and the start date with those funds to be applied to the \$50,000 purse of each race.

A Motion was then made by Stanley Roberts, seconded by Lewis Mathews to write the conditions of the Razorback as an open race (for colts/geldings and/or fillies) to allow 2 year old fillies a race in which to run, in the event the number of entries is insufficient to fill the filly race. A vote was taken and Motion passed unanimously.

The above led to a Motion being made by Stanley Roberts, seconded by Lewis Mathews that all races previously for colts and geldings be written as an open race (for colts/geldings and/or fillies - not restricted by sex) to allow fillies a race in which to run, in the event the number of entries is insufficient to fill the filly race of each stakes race category, which at this time includes The Rainbow and The Nodouble).

Brief discussion was held regarding the Awards Banquet and any suggestions for the one to be held next year. Bill suggested that we ask Eric Jackson to speak at our banquet next year and make the same presentation that he made to our Board at the beginning of this year. It was very informative and will give our members some insight into what has occurred over the years that ultimately got us to where we are today. The other directors agreed. Deana will ask Mr. Jackson if he will make the same presentation to our general membership at the Awards Banquet in 2015.

There being no further business, the meeting was adjourned.

#### Race Horse Reclaim Thoroughbred Rescue

As founder and director of Race Horse Reclaim a 501(c)(3) non-profit operation dedicated to Thoroughbred aftercare I am often asked what the history and motivation is behind creating and maintaining a project as work intensive and expensive as this developed into. We are now into our seventh year of taking in x-racers and working to re-home them; this is the story.

Let me begin by saying that this work is truly not for profit. Operating expenses at best break even with incoming donations. When that does not happen we (we being me and my husband Dr. Wayne Garland) cover the deficit from our own resources. While it would be nice to draw a personal salary for the work there are always more horses needing a soft landing and support; I feel fortunate to be in a position to work as the consummate volunteer.

The motivation to do this work comes from a deep deep love and sense of gratitude to the Thoroughbred horse. I experienced and enjoyed a thirty five plus year riding career during which I was mainly mounted on Thoroughbred horses. Back in the day (yes, I am of the vintage that can use that expression!) when dressage and jumping riding were developing in this country we Americans did not have access to the European breeds that dominated the international and Olympic sport. Most of us who were competing seriously were on American Thoroughbreds or crosses most of which were x-racers.

My foremost horse that took me around the country to the most prestigious dressage competitions of the time resulting in many national championships and a berth on the United State Equestrian Team was a \$5,000.00 claimer from the Charles Town race track in West Virginia. His registered name was "Little Davey" and I refined that to "David" as his show name. He enabled me to train with the top coaches of the Olympic squad at that time and paved the way to my riding other top horses, most of them Thoroughbreds, both here and in Europe. We were partners for over twenty years.

I retired from the show world and life fast forwarded. For business reasons of Dr. Garland's we found ourselves in Hot Springs Arkansas in the year 2006. Upon connecting with the local riding community I decided to acquire a horse for pleasure. Through a friend I found a lovely little Thoroughbred mare (that is now retired with us) whose breeder/owner had died. To outfit my horse I went to the tack shop owned by David and Mary Bell and through them other owners and trainers began offering me horses that were no longer racing. I went to Oaklawn during the 2007 race meet one day to see one or two and was overwhelmed by how many horses needed a place to go! To sum up this part of the story I took on a beautiful three year old gelding and then decided to find property where we could bring more x-racers and help them find homes. We found that farm in 2008 and from then on took in many horses during the subsequent race meets and throughout the year from the training centers in Hot Springs.

The most difficult part of the work beyond the labor and the money concerns is finding suitable homes for the horses. For that reason along with family considerations we returned to Florida, specifically Ocala that bills itself as the "Horse Capitol of the World" in late 2012. The horse show scene here is the nation's best especially in the winter months and good horses are in demand. The Thoroughbred as a performance horse is making a comeback in all circles and there are now shows just for them! We shipped with us a ten horse string of Arkansas/Oaklawn horses and have continued to bring down numerous others in the last two years. I even took in a starvation case in January that was Arkansas bred and had somehow come to Florida years ago!

The last three years the Arkansas Horsemen's Benevolent Protection Assoc.. and Oaklawn have donated to Race Horse Reclaim from the collected owners fund at the end of the race meets and a number of Arkansas breeders and race horse owners continue to donate. This support has helped us continue the work and insures that Arkansas horses have priority in being able to come into our program.

We are operating in a lovely efficient ten acre farm. However, we need to expand the size of the facility and are working to accomplish this in time for the 2015 Oaklawn race meet. At this writing I am looking at available properties. The big contingency is the financial ability to do this and we are going to need the help of continued and substantial donations which are tax deductible. Along with this article you will see some images of just a few of the Arkansas horses we have helped find new careers for. In our continuing ads with the ATBHA newsletter we will highlight more of these wonderful and deserving horses that have been with RHR. I have always and continue to maintain that Arkansas Thoroughbreds are some of the finest horses in the world and we are blessed to be able to help insure a safe future for them. So I close with heartfelt thanks to our Arkansas' friends and supporters and I look forward to a great 2015 season and race meet!



#### STALLION DEATH

UNBRIDLED'S RISK, was put to rest at Welch Farm in Ashdown, AR, May 28, 2014. He stood in Ashdown for 19 years.

By Unbridled's Risk (1993), Unraced. Sire of 12 crops, 70 foals, 46 starters, 25 winners, \$908,915, including Eagle Town (\$67,255, 3rd Rainbow S. [OP]), Will's a Player (\$45,241,2nd Rainbow S. [OP]), Nenantena (\$43,420, 3rd Rainbow Miss S. [OP]), Run Randy Run (7,810, 3rd Razorback Futurity [LaD]), Chases Comet (\$88,510), Loucille's Risk (\$84,227), Meeither (\$66,990), Jasons Jaxon (\$50,513, Walt M (\$47,475), Hide the Bridle (\$35,588).

If someone offers you a deal on a tractor that sounds too good to be true, then that someone is probably Steve Andersen. A lifelong horse enthusiast with decades of experience in promotional sales within the Thoroughbred racing industry, Andersen has since 2010 been placing his bets on his own company, which offers group purchasing benefits for horse owners in the United States and Canada.

Andersen's company, Equine Equipment Savings, gives discounts of up to 34 percent on Massey Ferguson agricultural equipment and Challenger commercial machinery; up to 26 percent on Toro commercial mowers and utility vehicles and Exmark commercial equipment; and up to 15 percent on Farm Paint products. There's no buy-in or membership fee, no time limit for the discounts and no horse farm too large or small to qualify.

"I didn't believe them; I'm always looking for the gimmick," said Gail Joyce, a Maryland horse owner who first learned about Equipment Savings at the 2013 Pennsylvania Horse World Expo.

At that point, Joyce was just beginning her search for a commercial mower to manage, as she put it, the "cantankerous piece of land" where she lives and stables her five horses.

"I wanted a high-quality product," she said, "and I didn't want to spend a lot of money on it. I took the information and came home and started shopping prices. I looked in several states, and I was stunned. I couldn't come close to beating the prices of Equine Equipment Savings, which were better than what the commercial repeat customers were paying. I was amazed."

She ended up getting an Exmark Lazer commercial mower for her husband as a gift.

"I got it from my local dealer and there was no catch," Joyce said. "It was good service and an excellent price. We actually wrote Equipment Savings a thank you letter because they did such a great job."



#### **How IT Works**

First, customers call Equine Equipment Savings. To qualify for a discount, a purchaser simply must be a horse owner and in the market for one of the participating products. The Massey Ferguson, Exmark, Toro and Challenger machinery have price entrance levels, all beginning with

their commercial models. All Farm Paint is also on the menu.

The Equine Equipment Savings representative will ask for your address, how many horses you have and how many acres you own. The rep will be an experienced horse person, knowledgeable about the products the program represents, and will be able to answer questions that only a horse owner would ask, such as "Do you have a single machine that will mow five acres, haul manure, fit the center aisle of my barn and drag my training track?"

"Then we contact your local dealer and let him know you're eligible," Andersen said.

The dealer uses the Equine Equipment Savings discount, which enables customers to shop in their neighborhood while receiving the same discount offered nationwide.

"I started this business because I knew manufacturers wanted to earn the equine market share," Andersen said. "They wanted to sell to the horse world, and I knew how to do it."

Foremost, Andersen is a horseperson himself. In the 1970s, he spent his teen years in Vermont, where he and his family would visit Green Mountain Racetrack.

"I went over one school night, made a lucky wager and won roughly \$1,000," he said. "I skipped school the next day and went over to buy a horse. I ended up with a \$1,000 horse in partnership with my sister. The next season we had one win, six seconds, a third and a fourth."

As a young adult, Andersen moved to Kentucky, where he made his way up to senior director of sales for a national trade organization. While working sales there and for other equine companies, he had an epiphany: I'm experienced in reaching equine markets, and certain manufacturers are trying to break in to the equine market. Why not start my own company to bridge the two?

He broached the idea to some major agricultural manufacturers, and by 2011 Andersen's new company had partnered with Toro and Exmark. In 2012, he forged an agreement with Farm Paint, and last year he added Massey Ferguson and Challenger.

Connie Wiezbicki, an Exmark dealer who owns Acres Power Equipment in Massachusetts, has sold a number of tractors through the Equine Equipment Savings program.

"We've used it, and it's worked exceptionally well," he said. "There are great savings, and they're factory authorized. It's a very interesting concept. Mowers, for example, we start at a minimum of \$5,000."

The price Wiezbicki mentions to qualify for the program is a reminder to buyers that Equine Equipment Savings applies to commercial mowers. Thus, a \$1,500 residential riding mower doesn't qualify.

Jim Overacker is a sales manager for Massey Ferguson in New York. Although he's been selling tractors for 35 years, he knew he had entered uncharted territory when, on a late September day, he attended the 2013 Saratoga Horse Expo with Andersen.

"It was 36 degrees and raining with a 35 mile-per-hour wind," Overacker recalled, but the event was packed with enthusiastic horse owners.

"It's opened the door for us into a totally new market, and you can't imagine the number of people associated with the horse community," he said. "When a so-called bargain like this comes out, I'm always very suspicious, but it's a benefit to the equine community and to the dealers. There's no game playing; it's straightforward."

Jim has now been working with Equine Equipment Savings for about a year. "Steve's more of a marketing team for us," said Lori Douglass, national sales manager for Farm Paint, an outdoor acrylic paint and roof-coating manufacturer that specializes in agricultural needs. "In order to get the discount and savings, you have to prove that you have horses. We're willing to give the farm a 10 to 15 percent discount if that's how a customer heard about us."

Terry Nickell, of Endeavor Farm in Midway, Kentucky, is a lifelong horseman who had this to say about his recent purchase of a Toro mower using the Equine Savings Program: "We have had several brands over the years but after some careful research chose a Toro, and we couldn't be happier. It is a workhorse, and we love it. The Equine Savings program works. It was easy to use, and we would recommend it to anyone."

#### SPREADING THE WORD

Because Equine Equipment Savings is still new, much of Andersen's mission focuses on getting the word out. To that end, he helps horserelated groups by donating items such as leaf blowers to raise funds for their organizations; the company also was a sponsor of the recent Texas Thoroughbred Association Awards Banquet and has partnered with the Thoroughbred Racing Association of Oklahoma, Louisiana Thoroughbred Breeders Association, North Carolina Thoroughbred Association and South Carolina Thoroughbred Owners and Breeders Association.

When it comes to horse groups, he said, "We support them on a local level. I just want everyone to know, big or small, that you can all save money with us. All I ask in return is that people hand out my flyers. Not only do we have the best equipment, but we also have the best discounts on it. When people see that discount, that's when the light goes on in their head.

"I love what I do," Andersen added. "My goal is to make the savings process simple for people so they will tell their friends."
