# Thoroughbred Incentive Program Approves 750 Shows for 2015

The Jockey Club Thoroughbred Incentive Program (T.I.P.) announced today that it has approved awards and classes for nearly 750 shows in 43 states and Canadian provinces during 2015. A full calendar of events is available on the T.I.P. website at *tjctip.com*.

The show disciplines include evening, dressage, Western and English pleasure, hunter/jumper/Western performance, games, and even polo and polocrosse.

"This program was created to encourage the retraining of Thoroughbreds into other disciplines upon completion of their careers in racing or breeding and it is obviously fulfilling that mission because in three years, we have offered awards at 1,100 horse shows in 41 states and provinces," said Kristin Werner Leshney, legal associate for The Jockey Club and coordinator of T.I.P.

In addition to awards fore shows, T.I.P. has renewed the Thoroughbred of the Year Award and the Young Rider of the Year Award. Applications for these non-competition awards will be available at <u>tjctip.com</u> in April with a deadline of June 30, 2015.

Only Thoroughbreds that have been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by The Jockey Club are eligible to participate in T.I.P. classes and compete for awards. All participating Thoroughbreds should have a T.I.P. number, which can be obtained at tictip.com.

Created and announced in October 2011, T.I.P. recognizes and rewards the versatility of the Thoroughbred through sponsorship of Thoroughbred classes and high point awards at sanctioned horse shows, performance awards, and non-competition awards. To date, T.I.P. has received more than 10,000 Thoroughbred entries competing for awards.

#### Tax Break of Racehorses Passes Congress

A provision that retroactively extends three-year tax depreciation for all racehorses was passed by the United States Senate late December 16 as part of bill H.R. 5771, the Tax Increase Prevention Act of 2014.

The bill, which extends retroactively through the end of 2014 numerous provisions which expired or were reduced at the end of 2013, passed the House of Representatives with overwhelming support on Dec. 3 and is expected to pass into law with President Obama's approval.

Maintaining the three-year recovery period for racehorse purchases has been a top legislative priority for the National Thoroughbred Racing Association since the provision's initial enactment as part of the 2009 Farm Bill.

"The renewal of three-year tax depreciation for racehorses indicates that lawmakers understand the contributions our industry makes to job creation and the country's overall economic health," said Alex Waldrop, NTRA president and CEO. "We are especially grateful to Senate Minority Leader Mitch McConnell (R-KY) and Rep. Any Barr (R-KY) for their leadership and support of this provision which is so important to horse owners and breeders."

The provision allows taxpayers to depreciate racehorses 24 months of age and younger when purchased and placed into service on a three-year schedule as opposed to a seven-year schedule. The accelerated schedule better reflects the length of a typical racehorse's career and is more equitable for owners.

H.R. 5771 also retroactively extends two other provisions that spur investment in race horses.

"Bonus depreciation" remains set at 50% and may be used by business owners who purchase and place in service qualified new depreciable property. This investment incentive permits taxpayers to depreciate in the first year 50% of qualified property purchased and placed into service. Yearlings that an owner purchases and puts into a training program are one example of eligible property.

The "Section 179 expense allowance" remains at \$500,000, which a \$2 million threshold for qualified new or used property purchased and placed in service by small business owners in many industries. Total purchases of qualified property that exceed \$2 million reduce the taxpayer's expense allowance dollar for dollar. Broodmares may be eligible for expensing and are an example of used property because of their prior use as a race horse or broodmare.

Information on H.R. 5771 can be found on the U.S. Congress website. The sections of key interest to the Thoroughbred industry are item 121 (racehorse depreciation), Item 125 (bonus depreciation) and Item 127 (expense allowance).

THE JOCKEY CLUB encourages use of the Jockey Club Interactive Registry. Submit your live foal reports on line. It's so easy. Jockey Club Rules regarding Live Foal/No Foal reports state:

Live Foal/No Foal Report (LF/NF). "Within 30 days of the birth of a foal, the owner, breeder or authorized agent must complete a Live Foal/No Foal Report. The LF/NF indicates the exact date of foaling, the sex of the foal and the state or Canadian province where the foal was born. It is at this stage of the registration process, that the breeder of the foal and correct address for receiving correspondence and the Certificate of Foal Registration must be supplied. In the event the breeding did not result in pregnancy or the pregnancy was lost during gestation, a No Foal Report should be completed and submitted to The Jockey Club as soon as possible.

#### OAKLAWN JOCKEY CLUB ANNOUNCES PURSE INCREASE

Oaklawn Park is known in past years for increasing their purses as revenues from the gaming center increase. 2015 is no different.

Because of the expanded gaming center, Oaklawn announced it's first increase of 2015 which became effective Thursday, February 12, 2015. "To be able to increase purses this early in the season is a testament to the quality racing we've been offering," Racing Secretary Pat Pope said.

Overnight purses increase by \$1,000 and \$3,000 per race.

Pope announced lower-level claiming races and maiden special weights increase by \$1,000. Open allowance and claiming races for horses running for a tag of \$2,500 and up rise by \$3,000, and higherend maiden claiming races increase by \$2,000.

Oaklawn's minimum purse rises to \$19,000, with maiden special weights now \$61,000 and higher allowance races increasing to possibly \$68,000.

The expanded gaming center, open to 3 a.m. weekdays and 5 a.m. weekends. A national magazine recently named Oaklawn as "Best Racetrack/Racino in the Mid-South."

Director of Racing, David Longinotti, said "we have a unique business model that features live racing, Instant Racing and electronic games of skill. And what we are seeing is that the total is greater than the sum of the parts. It's working."

Longinotti went on to say about the purse increase, "If the business trend we saw in January continues through February, there's a very good chance we'll be doing this one more time."

We are pleased at the number of restricted Arkansas-bred races that have filled and the field sizes. We hope the Arkansas-bred stakes races run with as many entries as we've been seeing.

President McDowell asked if there were any corrections or discussion regarding the Minutes from the April 2, 2014 meeting of the ATBHA Board of Directors. There being none, Val Yagos made a motion to accept the Minutes as presented, seconded by Linda Anderson, and unanimously approved.

The first item was a report on the current status of the Purse & Awards Fund for 2014. A final report on the 2014 deposits and expenditures will be given at the next meeting.

The next item was a membership proposal from T.O.B.A. Bill explained their proposal and that he had talked with Oaklawn about T.O.B.A.'s desire to hold a seminar for New Thoroughbred Ownership at Oaklawn either February 21st or 28th. The annual membership dues would be no more than \$1,000. After discussion a Motion was made by Susan Watkins for A.T.B.H.A. to join T.O.B.A. for one (1) year and that membership be reevaluated to determine the advantages of membership before renewing an additional year, seconded by Libbie Thiel. A vote was taken, those voting in favor were Linda Anderson, Libbie Thiel, Susan Watkins, Val Yagos and David Whited. Those opposed were Stanley Roberts, Lewis Mathews, Jr. and Tim Martin. Tommy Ives abstained. Motion passed by a majority.

Next was discussion regarding the recent and future Razorback and Lady Razorback two-year-old registered Arkansas-bred races. After discussion, a Motion was made by Linda Anderson for the Horsemen's Committee to discuss with Oaklawn's administration our desire to have these two races run at Oaklawn Park beginning in 2016. ATBHA would ask that these two races run as early in the meet as possible and that the purses be \$75,000 each (Oaklawn and ATBHA each contributing one half of each and ATBHA be given credit for enter and start fees). All other conditions would remain the same. Additionally, the name(s) would most likely have to be changed because Oaklawn already has a Razorback Handicap. The motion was seconded by David Whited and unanimously approved.

It was then brought to the board's attention that one of our members had asked if an additional condition could be added to future stakes races stating "starters would have preference over non-starters" ... after discussion, this matter expired for lack of a Motion.

The next item concerned the Arkansas Breeders' Stakes (filly division). After discussion a Motion was made by Libbie Thiel, seconded by Susan Watkins for the Horsemen's Committee to discuss with Oaklawn's administration the return of the Arkansas Breeders' Stakes (filly division) race in 2016 at either 1 mile or 1 1/6 mile. A vote was taken and Motion passed unanimously.

Bill McDowell then presented a suggestion to entice more Arkansas-breds to start in open company races. A.T.B.H.A. would pay a Two Thousand Dollar (\$2,000) incentive supplement to the owners of registered Arkansas-breds when their registered Arkansas-bred wins an open company race at Oaklawn Park during the 2015 racing season, excluding all stakes races. This would promote owners to run in open company races and add interest in owning Arkansas-breds. These fund would be paid from the Arkansas Racing Commission Purse and Awards Fund and shall be disbursed pursuant to current Arkansas law. After lengthy discussion a Motion was made by Stanley Roberts, seconded by Susan Watkins, that the Horsemen's Committee discuss with Oaklawn Park administration ATBHA's desire to have this added incentive for Arkansas-bred winners in open company for 2015. Upon their agreement, ATBHA will obtain final approval from the Arkansas Racing Commission. A vote was taken, Motion passed unanimously.

Next was discussion regarding the 2015 claiming prices of restricted Arkansas-bred claiming races and the number of MSW in the first condition book. It was acknowledged that these are matters regularly discussed at the meeting with Oaklawn and ATBHA's Horsemen's Committee.

Next Lewis Mathews related a suggestion made to him as a means of selling Arkansas-breds, wherein a specified date/time would be set aside for a "Yearling Farm Sale" on the Monday or Tuesday after the Rainbow/Rainbow Miss, which is right before the Racing Festival of the South. The ATBHA web-site and several pages of the newsletter would list all horses for sale, their individual breeding information, and the farm in the Hot Springs area where they will be located on the date specified. There was discussion as to the vetting and x-rays of the horses and that those could be arranged at the prospective buyer's expense. After extensive discussion, Stanley Roberts made a motion stating that he thought this was a very good and doable idea, but that it be tabled to allow more time to plan and prepare such an event. Tommy Ives seconded the motion and it passed unanimously.

Bill McDowell advised the directors that ATBHA had received a bill for sponsorship of a table at the "Kick Off" Banquet. He further mentioned that he had also received one personally. Instead of ATBHA and McDowell Farm both buying a table, since several of the directors sponsorship their own table or have arrangements to sit with someone else, President McDowell suggested that he split the \$500 sponsorship cost with ATBHA, each paying \$250 instead of \$500. Stanley Roberts moved to accept President McDowell's proposal for ATBHA to split a table sponsorship with McDowell Farm, seconded by Lewis Mathews and unanimously approved.

Next was 2015 Oaklawn Today sponsorship. During discussion it was suggested that, after approval of Oaklawn and the Arkansas Racing Commission, ATBHA's ad on the Oaklawn Today include information about the Incentive Supplement payment to the owner of registered Arkansas-breds that win in open company in addition to other incentive awards paid to the owner, breeder and stallion owners of registered Arkansas-breds. It was also mentioned that Oaklawn Today would be a good outlet for advertising a Yearling Farm Sale at such time plans are completed and one is scheduled, Stanley Roberts moved to approve ATBHA's 2015 sponsorship, with a new ad as discussed, seconded by Susan Watkins and unanimously approved.

Bill then mentioned that he had talked to Deana Echols about not retiring, but rather working the days and hours, as needed, to carry out the responsibilities and maintain the office work as in the past, especially flexible during the slower summer months of the year, thus allowing her more time off. It was suggested that she forward the office phone to a cell, when necessary. Brief discussion was held and a Motion was made by David Whited, seconded by Susan Watkins to allow Deana to work the days and hours as is required for her to carry out all responsibilities and tasks of operation of ATBHA, with no other changes. Motion was unanimously approved.

There being no further business, by Motion of Susan Watkins, seconded by Linda Anderson and unanimously approved, the meeting was adjourned.

# MINUTES OF ANNUAL MEETING OF THE GENERAL MEMBERSHIP

#### ARKANSAS THOROUGHBRED BREEDERS' & HORSEMEN'S ASSOCIATION

The annual meeting of the General Membership of ATBHA was held Friday, March 28, 2014 at The Clarion of the Lake, Hot Springs, AR. President Bill McDowell presided over the meeting. The meeting was called to order.

President McDowell stated that the minutes from the previous meeting were given to each member as they came in this evening. He asked if there were any questions, corrections or discussion regarding them. There being none, Tommy Ives made a motion to approve the minutes as presented, seconded by Stanley Roberts. Motion passed unanimously.

President McDowell then announced that the ATBHA Board of Directors had unanimously voted to move the 2014 Razorback and Lady Razorback from Louisiana Downs to Remington Park in Oklahoma City. He explained that the purses would remain the same as in the past, \$50,000 each, with ATBHA funding the entire amounts of each, as has been done the past several years in Louisiana. The date chosen by our Board and approved by Remington Park for both of these races is Saturday, November 8, 2014. The audience applauded this change.

President McDowell then announced that Registered Arkansas-breds earned \$5,700,000 in 2013, which was \$1,000,000 more than in 2012. This meant we were paying Breeders' awards on that additional \$1,000,000, so the Breeder awards percentage for 2013 would be 11.25%, down from 13.25%. It's always rewarding to see the total earnings increase by \$1,000,000 in one year!

He asked if there were any questions or comments. There being no further business, the annual meeting of the General Membership of ATBHA was adjourned and the awards banquet continued.

I spoke with a horse breeder from Texas that usually foals all of his mares in Louisiana. He is foaling a few in Arkansas this year. It's encouraging to see people taking notice of our program and bringing out-of-state mares to our Arkansas stallions.

I haven't talked about Oaklawn yet and that's our most important subject going on right now; with the new gaming expansion and 60K MSW purses. Things are looking pretty good for horse racing in Arkansas!

Preliminary figures indicate the percentages that will be paid this year for 2014 Breeder, Owner & Stallion Awards will increase over those paid last year. That's always a welcome announcement. To make it even better, since the gaming expansion at Oaklawn didn't open until early last month, it's a pretty sure bet that the wagering revenues on the Electronic Games of Skill will increase even more this year which means an increase of funds paid into the Purse and Awards Fund. One more plus, thank you Oaklawn ... a percentage of the wagering handle of the new ADW "Oaklawn Anywhere" is also paid into our Purse and Awards Fund. If you haven't used Oaklawn Anywhere, check it out. It'll make your life easier and A.T.B.H.A. benefits from you using it!

I hope some of you took advantage of the thoroughbred owners seminar that T.O.B.A. (Thoroughbred Owners & Breeders Association) held at Oaklawn earlier this month. You can't get too much information in this business, you can learn something new every day!

Our awards banquet, membership meeting and election are all coming up next month. I hope to see you at the banquet and at Oaklawn ... both events are sure to be fun!
